Minutes

Approval of the February minutes was deferred to the April board meeting.

President's Report Brenda Bye

- Farmer's Market (FM) Table. We are currently prepared to staff the clinic table booth, on the fourth Saturday of the month, from April to November. We will set up next to the Master Food preservers booth.
- We are considering providing a clinic table one time only on a Wednesday. We are also looking at running a trial booth at the Philomath FM which is held on Sundays.
- The FM chairperson position is still vacant. Signe Danler and Gill Seid are assisting with initial coordination. A future goal is to provide a standardize process for all pop-up clinics and FM booths.
- OMGA Rep Vacancy: We have an immediate need to fill this position. It is anticipated that the Alternate OMGA Rep will assume the position of OMGA Rep in 2025. Rich T had announced previously that he would not be continuing as the Rep next year.
- The MG trainees will be meeting at the Demo Garden for a garden tour and introduction to BCMGA committees on March 23 2:00-4:00pm. Otillia stated that she does not need to have a traditional education aspect. A discussion ensured with

recommendations to include an overview of OMGA/BCMGA & Extension relationships, and a committee fair. Otillia will provide a projector and any other office materials needed. We will need a representative from each committee.

Treasurer's Report Janet Magadanz

 The February financial report was presented and reviewed. Janet noted that most of the expected money from Insights has been received.
